Dear President Denton,

Congratulations! The Board of Commissioners of the Baccalaureate/Graduate Degree Commission met on April 20-21, 2015 and voted to grant initial accreditation to Douglas College with notes for your business programs.

Conditions and notes indicate that either the Standard or Criteria is not fully met, and should be viewed as an opportunity to move your program to a higher level of excellence. It would be extremely rare that a school receive accreditation without these conditions or notes given ACBSP's Core Value of Continuous Improvement and Organizational Learning, that "Business schools and programs should pursue regular cycles of planning, execution, and evaluation of every process and system. Ongoing improvement of these processes and systems leads to ever higher quality and student/stakeholder satisfaction." The notes placed on your programs are:

Note on Criterion 4.2: As the collection of results is in early stages, the CBA department would benefit from the inclusion of additional data points over a longer period of time for all measures to improve validity and to identify trends.

Note on Criterion 4.4: A direct link between assessment results and specific improvements to programs may enhance the identification of effective changes.

Note on Criterion 5.3: As the CBA department has a goal to increase the number of academically qualified faculty members, please continue to report progress until it meets the historically acceptable level.

Note on Criterion 5.8: The CBA department should develop a process to collect information regarding the scholarship activities of all faculty members and document the results in a table illustrated in Figure 5.6 of the Standards. "It is expected that each faculty member be continuously and actively engaged in scholarship and professional activities. 'Actively involved' intentionally implies that meeting attendance, though desirable as a professional activity, is not sufficient to demonstrate active engagement in scholarship. The concept of 'reasonable balance' indicates that all four areas of scholarship and professional activities should be represented in the activities of the faculty as a whole."

Note on Criterion 6.3.7: As improvements are currently being implemented to the enrollment management system, please continue to report the results of the improvements.

Dear Dr. Stroppa:

The Baccalaureate/Graduate Degree Board of Commissioners met on April 27 – 29, 2017 and reviewed your Quality Assurance Report. After review, the board voted to accept your report. The Board provided the following comments:

Note on Standard 5: The business unit has an opportunity to report via a range of relevant graphs on faculty and staff focus. Currently the business unit appears to be focusing on reporting hiring efforts in order to achieve an AQ faculty ratio of 40%. The business unit has an opportunity to identify additional performance indicators and provide a more rounded perspective.

Note on Standard 6: The business unit is in the process of revising the BBA Curriculum, and these revisions should follow the process book and will need to be reported when they become available.

OFI on Standard 3: Stakeholder satisfaction could be tracked more effectively if targets for results of actions taken and the improvements included more specific metrics for the action plans.

OFI on Standard 4: While the three MFT based graphs for the BBA are adequate for summative evaluation and external benchmarking of the program, the CBA stands to benefit moving forward if the other graphs representing formative and summative assessments were replaced. Measures that are not primarily based on grades, but focus upon achievement of specific learning outcomes are more effective.

A report on the progress to remove the Notes is due on **2/15/2019**. Your next full QA Report is due on **2/15/2021**. Your ten-year reaffirmation will be due in **2025**.
