What documents do I need to work in Canada?

✓ **Study permit with a condition that allows you to work**

The conditions are usually listed under Remarks or Conditions sections at the bottom

This means Study Permit itself is not a permission to cross the border. You need either TRV or eTA to enter Canada.

Conditions and remarks

You must have one of the following conditions or remarks printed on your study permit in order to apply for a SIN at Service Canada:

- *May work 20 hrs per week off-campus or full-time during regular breaks if meeting criteria outlined in section [186\(v\)](#) of IRPR*
- *May accept employment on or off campus if meeting eligibility criteria as per [R186\(f\), \(v\) or \(w\)](#). Must cease working if no longer meeting these criteria*



If your study permit does NOT have these indications or prohibits you from working as an academic student, you should apply for an update. Please talk to one of us to discuss your situation.

What documents do I need to work in Canada?

✓ Social Insurance Number (SIN)

- SIN is nine-digit number for tax purpose that you need to work in Canada legally.
- **SIN itself is NOT a permission for you to work in Canada.**
- Apply online on Service Canada website and upload your study permit copy.

Use of your SIN
You are required to provide your SIN to your employer within three days after the day you receive it. Also, some programs and/or services authenticate a person's identity using data on the SIN record; ensure you are using the names as shown above.

If your SIN begins with the number 9
You must present a valid proof of authorization to work in Canada to your employer. Your SIN record must always be updated to reflect the most recent expiry date.

EXAMPLE ONLY

What is considered as FT at DC?

- Each institution defines FT, PT, and scheduled breaks.
- For the purpose of work in Canada, DC students need to register for 9 credits or more throughout a semester to be considered as FT.
- If you register less than 9 credits, you are a PT student.
- Students who withdraw from courses will not be counted as FT students from the moment enrolled in less than 9 credits.
- The courses with W, UN, UNW, FD, and AUD grades will not be counted towards the FT course load.
- Certificate/PDD students need to be registered in **at least 9 credits in each semester (except final semester).**
- Some programs have different program requirements.

It is **your** responsibility to understand and maintain full-time status if you want to work on and/or off campus in Canada.

- Consider:
 - Pre-requisites & grades
 - Course availability/offering
 - Program length
- Resources:
 - Use the [course scheduling tool](#) to plan your schedule before you register
 - See an [academic advisor](#) to discuss your academic plans
 - Keep note of [dates and deadlines](#)
 - Visit the [Learning Centre](#) for academic help

Eligibility Requirements:

- Have a valid study permit with one of the following conditions or remarks:
 - May accept employment on or off campus if meeting eligibility criteria as per [R186\(f\), \(v\) or \(w\)](#). Must cease working if no longer meeting these criteria.
 - This permit does not authorize the holder to engage in off campus employment in Canada. **May accept employment only on campus** if meeting eligibility criteria as per R186(f). Must cease working if no longer meeting these criteria.
- Be a FT student
- Have a valid SIN

On-Campus Work – where?

- ✓ On-campus work is an employment opportunity within the boundaries of the campus (i.e. bookstore, offices, or cafeteria)
- ✓ **ELLA and Academic Foundation students** can work on the campus where they are studying FT
- ✓ There is no IRCC rule restricting on hours working on-campus
- ✓ You may hold an **on-campus job AND an off-campus job** as long as you are eligible to work on and off-campus.
- ✓ You **must** stop working on the day you are no longer studying FT or when your SP expires

How to Apply:

 - Apply for the job that you are interested in – You need a resume, cover letter, and references
- Use the Career Centre for support**

Eligibility Requirements:

- Have a valid SP with one of the conditions/remarks that allow you to work off-campus
- Have a valid SIN
- Be a FT student in an academic program that leads to a degree, diploma or certificate – **No ELLA or Academic Foundation students**
- Started studying in a program that is at least 6 months in duration

→ Use the [self-assessment tool](#) to see if you are eligible to work off campus without a WP

If you are eligible, your study permit allows you to:

- Work up to **20 hours per week** during **academic sessions**
- Work full-time (more than 20 hours) during a Summer semester regardless of your course load - if you are in the program that is eligible to make a Summer semester as a regularly scheduled break
- Work full-time during regularly scheduled breaks
- Failure to abide by conditions can result in ineligibility for work or study permits in the future (six-month ban R221 or inadmissibility) or deportation...

What is a “regularly scheduled break”?

- Breaks that are part of the DC [academic calendar](#)
- Varies depending on your program and registration status
- To work, must be FT **before AND after** your scheduled break

- Breaks between two semesters (after the **last day of exam period** to the first day of the next semester)
- Study break in February (1 week)
- Summer semester (from the first day of classes to the day before the first day of classes of the Fall semester)
 - Only if you and your program are eligible for Summer break
 - If a Summer semester is your first/last semester, it is NOT a scheduled break

Students cannot create their own schedule break.

Generally, if students do not register into classes in the Fall or Winter semester, it may have consequences like:

- Not being eligible to work:
 1. Until become FT again
 2. During regularly schedule breaks
 3. In the last semester being PT
 4. While waiting for the process of your PGWP application
- Possible PGWP refusal
- DC has to report students' registration status to IRCC in Winter and Fall – so IRCC will know

Need to take a semester off in Winter or Fall? → Talk to advisors

- In a program eligible for Summer break
 - FT in Winter and Fall
 - Meet other eligibility criteria to work off-campus
- Able to work FT in Summer while enrolled with no course/PT/FT

How many hours can I work?

If you meet all the eligibility requirements:

- On-campus work → FT
- Regular semester → 20 hrs/week
- Scheduled break → FT
- Program with no Summer break → 20 hrs/week

How many hours is FT work?

→ No set hours by IRCC

Can I work for more than one employer?

→ Yes, as long as you do not exceed the max hours

If you maintained FT status during your program,
You may work **PT** off-campus [in your final semester](#),
regardless of the number credit you are registered.

- With less than 9 credits, you are a PT student, but you can still work PT off-campus in the final semester
- **NO, you cannot work FT in your last semester.** I don't know where the rumor started.

Students who:

- Completed a program of study, **and**
- Start a new program after a semester break
may work off campus FT during the semester break

if you:

- Have a valid SP or applied for SP extension
- Meet the eligibility criteria to work off campus [[R186\(v\)](#)]
- Received an LOA for the 2nd program
- Received a graduation letter from DC Grad office

Why Co-op? :

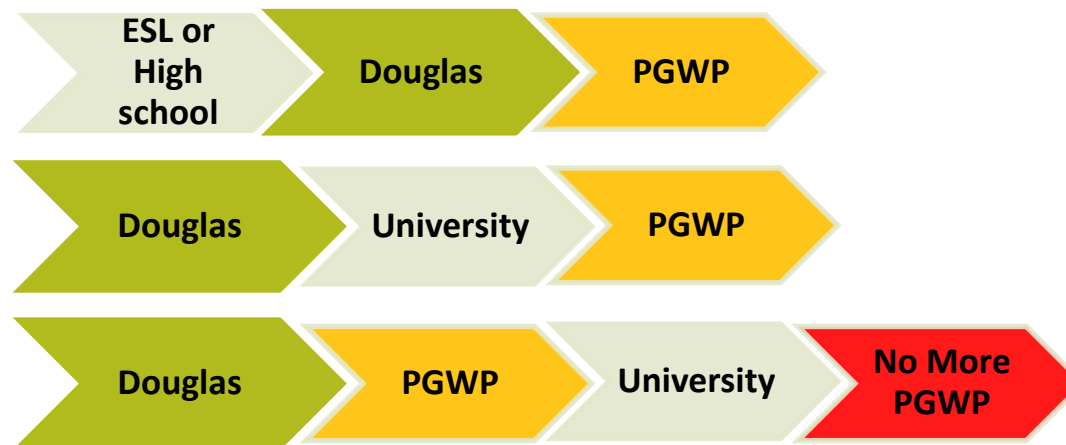
- You will gain Canadian full-time work experience while being international students

Post-Graduation Work Permit

The Post-Graduation Work Permit is a **ONE time privilege** for international students who graduate from certain Canadian post-secondary institutions and meet all the requirements
