OUTSTANDING YOUNG ALUMNI AWARD Terms of Reference

I. Confidentiality

All submissions received will be kept confidential by the Outstanding Young Alumni Award Committee and by the Board of Directors of the Douglas College Alumni Association.

II. Eligibility and Selection Criteria

The following criteria will be used to determine the eligibility of alumni nominated for the Outstanding Alumni Award and to select the winner(s) of the award:

- 1. The nominee must have graduated from Douglas College with a recognized degree, diploma, or certificate program*
- 2. Must be under 35 years of age at the time of the awards ceremony
- 3. Must be recognized as an emerging leader in their field of endeavor
- 4. Have made an outstanding contribution to their profession, field of study, volunteer organization, community (local or global), Douglas College, or Cape Douglas College Alumni Association
- 5. Their reputation, achievements and contributions of the nominee must bring honour and prestige to Douglas College and the Alumni Association
- 6. Must set an example for future young alumni to follow
- 7. The following persons will not normally be considered as nominees:
 - a. Currently active politicians
 - b. Currently serving members of the Alumni Board of Directors
- 8. The candidate(s) selected to receive the Outstanding Young Alumni Award is/are expected to attend the presentation ceremony to receive the award
- 9. In any given year, the pool of eligible candidates shall consist of all valid nominations received over a 36-month period ending March 1 of the year to be awarded
- 10. The committee will only review information as part of a valid nomination package (see section IV)

III. Timing

- 1. The committee will accept nominations continuously throughout the year
- Completed nomination packages must be received by March 1 of the year of the award (nominations received after this date will be considered for the following three years)
- 3. The Alumni Association Board of Directors will select (a) winner(s) of the Outstanding Young Alumni Award by April 1 of the year of the award
- 4. The Outstanding Young Alumni Award will be presented in the month of June

5. The successful candidate will be contacted during the beginning of April

IV. Information to be Submitted

A valid nomination package will consist of the following:

- 1. One prescribed nomination form (maximum of two typed pages)
- 2. Two prescribed third party supporting statement forms (maximum of one typed page), at least one to be from an individual who has direct knowledge of the nominee's professional qualifications, abilities and reputation
 - a. Let his/her name stand in nomination
 - b. Agree to attend the presentation ceremony if selected to receive the Outstanding Young Alumni Award
- 3. Current Curriculum Vitae of nominee

NOTE: The nominator must complete the nomination form and collect the two completed supporting statement forms and the completed release form and submit them as a nomination package.
