# 5.1 **Proposal for Change in Review Procedure for Curriculum Guidelines**

The Chair introduced the item and welcomed Nicole Vittoz, Chair of the Curriculum Committee, to speak to the item.

The Curriculum Committee is proposing to improve the workflow and quality of review for course curriculum guidelines by extending the review process. Currently, the Committee has a two-day review and consultation process which is extremely rushed. The additional time should improve the process and lead to better decisions.

Discussion ensued with respect to adding one month to the Committee's review process. The Chair clarified that the Committee will continue to summarize the curriculum proposals reviewed monthly, and bring recommendations to Education Council for short-cycle approval.

A member expressed appreciation for the additional time proposed and that having access to the committee will benefit newer faculty from a learning perspective.

The Educational Policies Committee is recommending changes to the Appeal of Final Grades SOP and Flowchart. There are no changes to the policy. The proposed changes include:

- Clarification about informal resolution as Step 1,
- Clarification about circumstances under which a student may not be able to continue with a subsequent course while an appeal is underway,
- Clarification about the decision-making process in the absence of the instructor, and
- Time lines for the various steps in the process
- Language updated to be gender-neutral, and to include current nomenclature.
