# 1. TRADITIONAL TERRITORIAL ACKNOWLEDGEMENT

The Chair acknowledged that the campuses of Douglas College are located on the unceded traditional and ancestral lands of the Coast Salish Peoples, including the territories of the díčəỷ (Katzie),  $q'^wa$ : nੈ $\lambda'$ ən (Kwantlen), k<sup>w</sup>ik<sup>w</sup>əÅəm (Kwikwetlem), x<sup>w</sup>mə $\theta$ k<sup>w</sup>əýəm (Musqueam), and qiqéyt (Qayqayt) First Nations.

## 5. <u>NEW BUSINESS (Notice of Motion) Items for Council Approval</u>

5.1 <u>Student Appeal Educational Appeals Policy – Academic Appeals Committee</u>

The Chair advised Council Members that he received an email regarding a student appeal. The composition of the Academic Appeals Committee consists of the Chair, Vice Chair and one other member of Council. The Chair suggested that S. Schechter, Chair of the Policies Committee, be the third person appointed.

#### 6. <u>NEW BUSINESS (Notice of Motion) – Items for Council Advice to the Board</u>

6.1 <u>Program Revision: Bachelor of Social Work</u> L. Becker spoke to the item.

The residency requirement has been increased from 25% to 40% to align with the changes approved in the Credentials Awarded at Douglas College Policy.

The substitution of AIST (Applied Interdisciplinary Studies) courses AIST 3030 and 3040 will allow SOWK students to receive credits for international field schools and practicum experiences.

# Program Revision: Bachelor of Science in Psychiatric Nursing

J. Crisp spoke to the item.

The program updates relate to the non-academic admission requirements. There are no changes to the curriculum. Changes include the removal of the admissions interview, an edit to the cumulative GPA (to reflect C+ in all courses) and the addition of more robust Learning Outcomes for students.

#### 6.3 <u>Program Revision: Certificate in Education Assistance and Inclusion</u> S. Polushin spoke to the item.

The proposed changes better align with the K-12 curriculum and remain competitive with similar public post-secondary programs. The change to the Residency Requirement from 25% to 50% will bring it in line with current policy.

# 6.4 <u>Program Revision: Global Competency Certificate</u>

J. Bourget spoke to the item.

J. Bourget advised that the proposed revisions to the Curriculum Framework are mostly stylistic and have been updated for clarity and consistency for students. Changes have been made to the lists of GCC-eligible courses and experiences; Learning Outcomes, Program Outcomes and the Global Competencies section.

Recommendations were received from the VEST (Vocational Education and Skills Training) comprehensive program review that the name of the Basic Occupational Education program does not reflect the complexity of the available curriculum options. The VEST Department endorsed the name Local Industry Skills Training (LIST) to replace the outdated name, Basic Occupational Education.

# 6.13 <u>Educational Affiliation: Duale Hochschule Baden Württemberg Cooperative State</u> <u>University (DHBW), Germany</u>

J. Zhao spoke to the item.

Zhao provided an overview of the information and highlighted some of the unique features of the institution. In addition to traditional exchange and short-term programs, DHBW is open to supporting Douglas students completing internships or practicums in Germany. Developing international work–integrated learning (WIL) opportunities for students supports our goal of strategically expanding study abroad



partners geographically and by type in order to support global citizenship development at Douglas College.

C. Cragg inquired whether the title of the new course could also be included in the Committee's report. L. Millis responded yes, that he is happy to accommodate that request.

The President thanked L. Millis for adding the detailed information. She noted that it is very valuable in terms of letting people know what might be right as a recommended elective for other programs.
