### 6. NEW BUSINESS (Notice of Motion) – Items for Council Advice to the Board

#### 6.1 Program Revision: Bachelor of Business Administration in Accounting, Concentration in Data Analytics in Accounting

D. Keighron spoke to the item.

This program revision adds two new courses created in the Accounting Department; ACCT 4880 – Applied External Audit and ACCT 3421 - Crypto Accounting & Taxation. One course is removed, ACCT 1222 - Computer Applications for Accounting, as it is already listed as a required course in the BBA program. Additional revisions include an update to the learning outcomes as well as updating the GPA requirement to align with the Credentials Awarded Policy.

B. Younan, Registrar, advised that the curriculum framework already contains standard language for Concentrations. The Registrar will provide the initiator with the suggested wording by email to ensure alignment with all 17 concentrations in CBA. It was also suggested that the 'notes' indicated need to be captured in the FAQ section of the program page.

## 6.4

**Program Revision: Certificate in Global Competency**

J. Bourget spoke to the item.

This program revision proposes the following revisions:

- Removes the restriction on GCC-eligible Communications (CMNS) courses.
- Change from “self-paced” to “4 years” to align with the Credentials Awarded Policy for Certificates.
- Update to non-academic requirements to reflect the three categories available to students
- Convert GCC course list with course numbers only (no titles) to improve readability and simplify future course changes.

B. Younan, Registrar, commended the initiator for converting the course list into table format, making it much easier to maintain and update.

The Registrar recommended modifying the program duration from self-paced to a one (1) year timeline to align with the Credentials Awarded Policy. Students will continue to have a maximum of four (4) years to complete the program. Additionally, it was recommended that any course that is no longer offered from the GCC-eligible list, be removed.

## 6.5

**Full Program Proposal: Bachelor of Science in Computing Science**

S. Khosravi spoke to the item.

The proposed Bachelor of Science in Computing Science, is a joint initiative developed between the Department of Computing Science in the Faculty of Science and Technology and the Department of Computing Studies and Information Systems in

the Faculty of Commerce and Business Administration. Faculty members from both departments will deliver the program. The proposal also introduces two Concentrations, Concentration in Cybersecurity and Concentration in Game Development.

Discussion ensued. B. Younan, Registrar, provided the initiator with suggested revisions to ensure compliance with standard language used for multiple credentials, as well the standard language used for COOP (Co-Operative Education). Additional recommended revisions were noted and will be sent by B. Younan to the initiator via email.

The President expressed appreciation for the overall structure and design. She inquired about the transferability of the courses and if there were any pathways in particular to direct students to higher level education (i.e. pursuit of graduate studies).

S. Khosravi responded that a Program Advisory Committee was assembled and many letters of support were obtained from both academic and industry partners. All courses in the first year are transferable through the BC Transfer Guide. He continued that potential transfer partners include BC research universities such as SFU, UBC, UFV and KPU. The program offers multiple entry and exit points and supports laddering options for students.

M. Nicholson encouraged the initiator to consider adding course CMNS 1115 – Business Communication, as this course would align well with the proposed program.

The Chair expressed her appreciation for the new program and that it was great to see collaboration across faculties.
