5.1 Policy Items

- a) Grading Policy
- S. Schechter spoke to the item.

As part of its regular review cycle, the Educational Policies Committee is recommending changes to the Grading Policy as follows:

- Change grading scale
- Change description for a C-
- Change letter grade of P to D
- S. Schechter explained the rationale behind the recommendations. The changes to the grading scale are to align the College's grading scale with other post-secondary institutions to ensure Douglas College students are not disadvantaged when transferring to another post-secondary institution.
- S. Schechter advised that the Policies Committee did not have the chance to fully discuss the non-credit courses and that those who teach non-credit may want to retain the P grade or transition to a D grade. Discussion ensued.

The Chair requested that members take the information back to their constituencies for feedback at the December meeting when Council will consider a Motion to Approve the recommendations.

6.1 <u>Educational Affiliation: Universidad Tecnológica El Retoño – BIS, Mexico</u>

The Universidad Tecnológica El Retoño is being recommended for faculty-led programs such as field school, guest lecturing and joint research projects. In addition, student exchange affiliation is being recommended with opportunity for bilateral credit exchange, language and intercultural opportunities.
