JOB SUMMARY:

The Recreation Therapist ensures the provision of Recreation Therapy services in designated Assisted Living settings/programs focused on designated clients/residents, and coordinates and participates in quality improvement and risk management initiatives, meetings, research and education.

Provides Recreation Therapy assessments/interventions as required and provides leadership to designated students, staff and volunteers.

The Recreation Therapist is an integral member of the Menno Place team and is required to have a commitment to the vision, mission and values of Menno Place performing duties following Menno Place policies and procedures ensuring the provision of *Resident and Family Centred Care* (RFCC) while safeguarding staff and residents.

This position requires teamwork, communication, and cooperation. It is the expectation that an individual in this position contributes to a positive, safe working environment, takes instruction well and cooperates with their supervisor and co-workers. This person manages their time well and participates in continuous quality improvement of services provided.

DUTIES & FUNCTIONS:

- Provides recreation and leisure programs/activities one on one and in groups to clients.
- Assesses clients' recreation and leisure needs, develops, and coordinates the delivery of therapeutic recreation plans and evaluates outcomes/objectives.
- Performs recreation/leisure assessments to create therapeutic recreation programs that benefit the clients' health, functional status, personal development, and quality of life.
- Documents behavioral and functional observations. Develops individualized therapeutic recreation plans in collaboration with others.
- Monitors clients' progress, revisits goals, identifies accomplishments and sets/revises time lines to ensure objectives are met.
- Collaborates with Occupational/ Rehabilitation staff, other health care professionals, social and recreational groups in the resolution of client program issues.
- Contributes to the organization and delivery of Recreation Therapy services, and participates in designated quality assurance initiatives, meetings, research, and education, as required.
- Provides input to the Manager by participating in the development of procedures, research, and continuous quality improvement initiatives for the department.
- Performs administrative duties as required.

Education, Training and Experience

*Baccalaureate in Therapeutic Recreation or Leisure Studies from an accredited university.

*Two (2) years' recent, related experience working with the designated population group, in the applicable program area/setting, including one (1) year's experience

*Cardiopulmonary Resuscitation (CPR) and Emergency First Aid.

*Eligible for certification and CTRS credential with National Council for Therapeutic Recreation Certification (NCTRC).

Skills and Abilities

*Broad knowledge of research process and methodology.

*Demonstrated ability to function as a team member, leader, and facilitator.

*Demonstrated ability to teach clients/residents and co-workers both one-on-one and in groups.

*Demonstrated ability to communicate effectively with co-workers, other health care staff, clients/residents, and their families, both one-on-one and in groups.

*Demonstrated ability to integrate Recreation Therapy concepts and theories in a variety of settings.

*Demonstrated ability to work independently and in collaboration with others.

*Demonstrated ability to provide effective consultation.

*Demonstrated ability to establish workload priorities in collaboration with others.

*Physical ability to perform the duties of the position.

*Skill in the use of equipment, and in techniques appropriate to the treatment of clients/residents with a rehabilitation/degenerative disease or disability and/or mental health issue.

*Documented involvement as a research investigator and/or published researcher.

*Basic computer literacy.

*Comprehensive knowledge of evidence-based Recreation Therapy practice related to applicable program health issues and treatment.

*Comprehensive knowledge of theories and concepts of therapeutic recreation, leisure, social psychology and current trends and practice in designated areas.

*Comprehensive knowledge of recreation therapy theory and practice within a client/resident and family centered model of care.

*Comprehensive knowledge of organizing therapeutic recreation services including the development of a written plan or operation.

*Comprehensive knowledge of other health care disciplines and their role in client/resident care.

Health & Safety

- Is aware of their rights and responsibilities and follow all health and safety policies and procedures.
- Works safely to reduce the risk of injury to self, co-workers, and residents.
- Is alert to and promptly reports all actual or potentially hazardous situations to immediate supervisor. Does not operate or use faulty equipment.
