**O. Course Objectives:**

The student will learn the resources of diatonic four-part harmony, structural units and small forms, and the basic components of song.

The student will be expect to:

1. harmonize in four-part style a given tonal melody.
2. harmonize in four-part style a given tonal bass.
3. provide a harmonic analysis of a given passage of music.
4. provide a structural analysis of a given passage of music.
5. provide written answers (definitions, explanation, descriptions, etc.) about any area of content.

**P. Course Content:**

- A. HARMONY - including six-four chords modulation to first relationship keys; secondary dominants; secondary sevenths, all nonharmonic tones; modulating and nonmodulating sequence; harmonization of basses (figured and unfigured) and sopranos.
- B. STRUCTURE - binary and ternary form.
- C. SONG - strophic and through-composed; keyboard accompaniment; text setting.
- D. MISC. - musical terms and signs.

**Q. Method of Instruction:**

Lectures will include explanation of material by the instructor and practice by the student in the form of exercises.
